1. QI Macros Licensing

- 1.1. The QI Macros is a single user license. One license must be purchased for each user, regardless of whether the software is installed on a network or on individual computers.
- 1.2. Advocate will communicate QI Macros license terms to their clients and will remind their clients of license terms if there is reason to believe that a client is using more licenses than they have purchased.
- 1.3. This license agreement permits you to use one copy of the QI Macros on a single computer. By opening and using the QI Macros software, you are agreeing to be bound by the terms of this agreement. The QI Macros is owned by KnowWare International, Inc. and protected by U.S. copyright laws. You may transfer one copy to a hard disk. Any enhancements added to the existing macros are considered the property of KnowWare International Inc. You may not copy, rent, or lease the QI Macros or the documentation accompanying it.

2. Order Placement

3. Order Terms and Required Information

- 3.1. Billing and Payment: Advocate orders will be paid by credit card. Advocate bills their client.
- 3.2. Required User Information: Advocate will provide a physical address for their client on each order and will provide names and email addresses for each QI Macros license recipient. This information is required for order fulfillment and for providing technical support to QI Macros users.
- 3.3. Confidential Advocate Order Page: The Advocate order page is intended for direct input of orders by Advocate only. Advocate will not share this order page with clients or any third party under any circumstances.
